EXTERIOR PAINT – The colors must be one of the approved Groves at Baytree colors. The color schemes are in a book at Sherman Williams' Tavares store. Either identify by Color Scheme number or submit paint chips and indicate where each color will be used (body, trim, garbage door, front door, shutters, etc.) The guideline used to review house colors considers the harmony of the existing neighborhood and homes, external de sign, and the house colors of your next door neighbors. Earth toned colors can range from light to medium color intensity.

_____ SCREEN ENCLOSURE, PATION, LANAI, POOL, SPA – Submit lot survey with new construction drawn in and include a description of materials and colors to be used.

_____ DOORS (GARAGE, ENTRY, SLIDING, OR PATIO – Submit construction drawings or plans and include a description of materials and colors to be used.

LANDSCAPE – The Landscape Committee will review all requests for lawn or landscaping changes. You do not need to submit an Application for Architectural Review to make changes in existing flowerbeds if you are replacing with same size and type plants. Otherwise, submit drawings or plans of existing landscaping and include a description of the size of plants or trees to be used.

DRIVEWAY/ENTRY WALKWAY – Submit construction drawings or plans and include a description of materials to be used. Color of Driveway/Entry Walkway is covered in the Exterior Paint paragraph above.

_____ WINDOWS/TRIM – Submit construction drawings or plans and include a description of materials and colors to be used.

ROOF – Roof shingles must be of the same type currently installed. Color changes/style MUST be approved by the ARC. Only existing colors already in the The Groves at Baytree will be allowed. Any color request may be considered by the Board of Directors for inclusion in the Guidelines.

______ FENCE – Submit lot survey with new construction drawn in and include a description of materials and colors to be used. Color of fence is covered in the Exterior Paint paragraph above.

NO sheds, appliances, non-operational vehicles, boats, boat trailers, recreational vehicles, motor home, or similar vehicle shall be kept on any lot/property including a fenced-in backyard.

Should a homeowner make any exterior changes without prior approval of the ARC, HOA, and Management and/or without proper permits, homeowner may be required to remove and/or restore the property to its original condition.
